

## AMWS's Highlights for 2022 include;

- 1. One-off grants to MTS Hastings and Newcastle to repair storm damage
- 2. Two financial contributions to the Seafarers International Relief Fund 3. A focused financial grant to MTS Townsville in support of their welfare packages for Ukrainian Seafarers

4. Via a LOAM legacy, AMWS has been able to facilitate a cadetship programme on the STS One & All.

- 5. Via the Malcolm Longstaff Scholarship programme, AMWS supports AMC students who meet the Society's criteria.
- Overall AMWS has contributed almost \$250,000 for scholarships, grants and seafarer welfare in 2022

assist with the overall welfare of everyone in the port community. Paul opened the discussion with the vision and mission of Human Rights at Sea. He went

Abandoned Livestock carrier to be auctioned in Victoria. ITF Seafarers Press Release 19th December 2022.

An international livestock carrier ship, the Yangtze Fortune, has been detained by the Australian Maritime Safety Authority in Portland, Victoria, after its owner


failed to pay its crew or meet its obligations under international maritime law. The ship, which is registered under the Flag of Liberia but operates a trading route between Australia and China, has been anchored near Portland since October and is subject to an abandonment notice lodged with the International Labour Organization. The ship is also subject to Australian Federal Court proceedings brought by commercial creditors from Singapore to recover debts owed to them by the ship's owner.

After many weeks at anchor near Portland, provisions aboard the ship are running low and many of the crew are desperate to return home but must now stay with the ship while court action and the ship's sale process unfold. **Read More. ITV Seafarers Link >>**
